ORDER :

In the reference 1st cited the Chairman, Jeeva Educational Trust, No. 3, Sri Labhi Colony, Alwarpet, Chennai – 600018 in his letter dated. 24.08.2020 received by this University dated. 08.09.2020 had forwarded the “Essentiality Certificate” issued by the Government of Tamil Nadu, Health and Family Welfare Department, Chennai vide Lr. No. (Ms.) No. 323/MCA-2/2020 dated 03.09.2020 for starting of MBBS Course at Tiruvannamalai in the name and style as “Arunai Medical College and Hospital” from the academic year 2021-2022 with an annual intake of One Hundred and Fifty (150) MBBS Seats and the Chairman, Jeeva Educational Trust had requested to issue “Letter of Consent of Affiliation”.

In pursuance of the orders of the State Government and on the request of the Chairman, Jeeva Educational Trust this University conducted an Inspection. After examining the Inspection Report, in the reference 3rd cited, this University had issued a " Letter of Consent of Affiliation " to "Arunai Medical College and Hospital" Velu Nagar, Thenmathur Village, Tiruvannamalai -606 603 for the year 2021-2022 so as to apply to the Government of India, New Delhi for obtaining permission.

In the reference 4th cited the Dean of the above institution has requested to issue Orders of Provisional Affiliation for starting the MBBS Degree Course.

In the reference 5th cited, the National Medical Commission, New Delhi has conveyed the Letter of Permission of the Medical Assessment and Rating Board (MARB) for starting of a new Medical College in the name and style of "Arunai Medical College and Hospital", SF.No. 47/2, Velu Nagar, Thenmathur Village, Tiruvannamalai - 606 603 with an annual intake of One Hundred and Fifty (150) MBBS seats from the academic year 2021-2022 under section 26(1) (a) (b) and 28(1) (2) of the NMC Act, 2019.

This permission for starting of above mentioned MBBS Course and admission of students will be for such time the first batch of students admitted against the above course appears for the final examination in the subject. The college authorities may take up the matter for recognition of the qualification under section 35(2) of the IMC Act at the time of first batch admitted against the sanctioned intake appears of final examination with National Medical Commission.

In the reference 6th cited, on receipt of Letter of Permission this University has constituted the inspection team to verify the Infrastructural facilities, teaching staff etc., for considering the grant of **Provisional Affiliation Orders** for establishment of a new Medical College in the name of "Arunai Medical College and Hospital", SF.No. 47/2, Velu Nagar, Thenmathur Village, Tiruvannamalai - 606 603 with an annual intake of One Hundred and Fifty (150) MBBS seats from the academic year 2021 -2022. The inspection team submitted their report to this University which has stated that the infrastructural, teaching and other facilities are available and adequate as per required NMC Norms for the grant of Provisional Affiliation Orders.

In pursuance of the permission granted by the National Medical Commission, New Delhi and based on the reports of Inspection Commission this University grants hereby the orders of " **Provisional Affiliation** " for starting First MBBS Degree Course at "Arunai Medical College and Hospital", SF.No. 47/2, Velu Nagar, Thenmathur Village, Tiruvannamalai -606 603 with an annual intake of One Hundred and Fifty (150) seats from the academic year 2021-2022 subject to the following conditions.

1. Arunai Medical College and Hospital, SF.No. 47/2, Velu Nagar, Thenmathur Village, Tiruvannamalai -606 603 shall abide by the provisions of the Tamil Nadu, Dr. M.G.R. Medical University Act, 1987 (Tamil Nadu Act 37 of 1987) and by Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Medical Colleges framed from time to time.

2. The institution shall agree for the inspection of the College by the Tamil Nadu Dr. M.G.R. Medical University at any time according to the Statutes, Ordinance, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Medical Colleges framed from time to time.

3. The institution shall abide by the Statutes, Ordinance, Regulations and Rules framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, Curricular Activities etc., framed from time to time.

4. The conditions that may be prescribed by the National Medical Commission, New Delhi shall be fulfilled. The standard and requirement prescribed by National Medical Commission, New Delhi from time to time for admission to Medical Colleges shall be followed strictly.

5. The sanctioned strength for the MBBS Degree Course is **150 (One Hundred and Fifty only)** from the academic year **2021 - 2022**. The maximum number of students that may be admitted to the course shall not exceed the sanctioned strength.

6. The admission procedure as enunciated by the Supreme Court of India, shall be followed.

7. The admission procedure as laid down in Government order should be followed. While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly. Any admission made over and above will not be permissible on any account.

8. Only eligible candidates according to the regulations of this University shall be admitted.

9. The candidates should be admitted in the capacity of **150** seats before the prescribed cut off date for MBBS Degree Course and they will be registered to take up their Ist Year examination as per existing regulations.

10. The course should be conducted in accordance with the regulation and syllabus approved by this University and National Medical Commission, New Delhi.

11. The staff, student ratio prescribed by the National Medical Commission, New Delhi shall be followed. The staff pattern with prescribed qualification by the University as well as the National Medical Commission, New Delhi should be followed.

12. The Institution shall furnish all the teaching and other staff details with qualification, experience, date of joining etc., whenever required by the University.

13. Required furniture shall be provided wherever they are necessary.

14. Hostel accommodation shall be made available for the students.

15. The Institution shall furnish a budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the entire course of study. The management of the medical college shall show evidence of an annual income of not less than INR. 15,00,00,000/- (INR. Fifteen crores only) for the maintenance of the college and hospital.

16. The Security Deposit of INR. 1,00,00,000/- (INR. One Crore) i.e., Ist Instalment INR. 20,00,000/-, IInd Instalment INR. 40,00,000/- & IIIrd Instalment INR. 40,00,000/- created in the joint name of " The Registrar, The Tamil Nadu Dr. M.G.R. Medical University, Chennai & the Trust name of the institution in a Nationalised Bank / Government undertaking / Corporation. The Second and Third installment should be created and submitted to this University during 2nd and 3rd year.

17. The College shall furnish a "Utilization Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Medical College.

18. There shall not be any financial commitment either to this University or to the Government.

19. The Institution shall obtain the renewal permission of the Government of India for an intake of 150 seats every year and submit the copy of the same to the University.

20. The Institution shall obtain the recognition of the National Medical Commission, New Delhi for 150 seats and submit the copy of the same to this University.

21. Furnishing of false information to the University any matter or suppression of facts while furnishing information to the University or violation of any of the Statues, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.

22. Facilities should be made available for conducting University Examinations. During the University Examinations, the question paper will be sent through internet for which the following equipments have to be purchased and kept ready by the Institution.

Medical University (Affiliation of Medical Colleges) Statutes, by the end of 1st year MBBS Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the Second year MBBS Degree Course of study along with renewal permission obtained from the National Medical Commission, New Delhi.

Any other conditions which the University considers necessary to imposed from time to time to be followed.

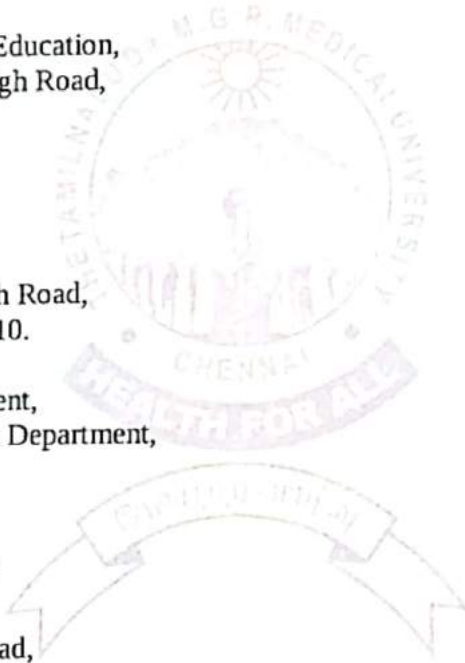
